## **Background**

## Objective

The objective of this contract is to obtain the services from a reputed, experienced, and qualified contractor who can provide efficient repair and maintenance services to SF Uganda's leased property as set below in the scope of work.

## **Scope of Work**

The contractor shall provide repair, maintenance, and installation services for the following work on the SF Uganda property:

- i. Electrical Repairs
- ii. General maintenance
- iii. Carpentry
- iv. Plumbing
- v. Painting

## **Assignment Details**

The contractor shall provide repair, maintenance, and installation services for the following work.

#### **Electrical**

- Routine check-up of all electrical systems and appliances, defective bulbs, tube lights, perimeter-wall lights, fans, switches, sockets, plug points, short-circuiting lines, re-wiring, load balancing and any other related jobs.
- A thorough check of all the electrical systems which includes cleaning of all panel junctions, tightening of all connections, checking/cleaning/greasing of all contracts, and checking of Main Circuit Breakers (MCBs).
- Installation of various office electrical devices and equipment.
- Be able to repair or arrange repair of all kinds of electric and electronic items.
- Frequency of intervention: Routine checkup for all the electrical work on a PERIODIC basis [Periodicity to be determined at engagement of contract].

### **General maintenance**

Routine check-up and set up of all general maintenance work on the floor, carpets, office blinds, and compound.

### **Plumbing**

Installation and repair of flush, shower, fixing leakages from pipelines both internal and external, surface drains and manholes.

# **Painting**

Painting should be environmentally friendly and should be undertaken in close liaison with the administration. The frequency of intervention is as and when required.

## Carpentry

The service provider will do the carpentry work on a when-required basis which will include.

- 1. Repair of chairs, cupboards, and tables.
- 2. Aluminium and wooden windows and doors
- 3. sealing doors and windows
- 4. fixing frames for doors and windows
- 5. Office partitioning

## **Eligibility Criteria**

- The Service provider must be able to provide service without initial deposits and invoice later for payment.
- the Service provider must be authorized and registered to provide listed services.
- The Service provider must have been in business for at least five years.
- The Service provider must be able to deal with equipment that fails during the contract period without hesitation.
