FUMIGATION AND PEST CONTROL, GARBAGE AND SANITARY WASTE COLLECTION AND DISPOSAL SERVICES.

Background

Strømme Foundation (SF) is an international Development Organization headquartered in Kristiansand, Norway with a global footprint in 9 countries in the regions of West Africa, East Africa, and Asia. SF is committed to empowering people to overcome the root causes of poverty through its thematic focus on Education, Livelihoods, and Job creation. Objective.

The primary objective of this Contract is to provide the requested services to SF (U) on Naguru Vale Road, Plot 15 Naguru, and to the Moyo Field office The service provider is expected to provide Fumigation and Pest Control, Garbage and Sanitary Waste Collection and Disposal services of high industry standards using environmentally friendly products and supplies. The entire responsibility will be of the contractor to supply the required supplies and the equipment/tools needed to ensure that the offices and compounds of SF (U) in Kampala and Moyo remain clean. The major work is summarized below.

Scope of Work

Fumigation and Pest Control

The major work is summarized below:

- Checks for rodents (monthly)
- Internal spraying for cockroaches, mosquitoes, and other pests (quarterly)
- External spraying for termites and ants (monthly)
- Pest control service every quarter
- Check for Snakes and laying repellent (monthly)

The quality supplies and the required equipment/tools must be provided by the contractor.

Garbage and Sanitary Waste Collection and Disposal services

The major work is summarized below:

- Garbage and Sanitary Waste Collection
- Disposal Services
- Sorting and disposal of garbage & Sanitary waste (organic and inorganic).

The frequency of garbage collection per week is daily from Monday to Saturday while that of Sanitary Waste Collection is Monthly.

The supplies and required equipment/tools must be provided by the contractor.

Location

The service provider can provide services to Either both offices or choose one officeThe total planned requirement in this scope of work is fixed at SF (U) on Plot 15 Naguru Vale Road and SF field Moyo Office

Eligibility

- The Service Provider must be able to pick up garbage and sanitary waste promptly and safely without causing any health hazards.
- The Service Provider must have a final waste and garbage disposal site which should align with local disposal laws.
- The Service provider must have the ability to always safeguard SF by ensuring the confidentiality and safety of office equipment while accessing office premises, and demonstrating what measures they have in place to protect confidential information in the office.
- The service provider must guarantee the safety of office equipment while at the premise and exhibit security vigilance with the deployed workers.
- The Service Provider Must be able to provide service without initial deposits and invoice later for payment.
- The Service Provider must be registered and authorized to provide services.
- The Service Provider must have been in business for at least five years.
